MEMORANDUM OF UNDERSTANDING (MOU)

BETWEEN

WHEREAS:

- D) SmarTec IT Solutions, Hubli-Dharwad the Second Party is engaged in services like Software Development, IT Training, Networking Services, CCTV Camera Surveillance System, Biometric Device, Bulk SMS Services.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

CLAUSE 1: CO-OPERATION

- 1.1 Both Parties are united by common interests and objectives, and they shall establish co-operation.
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities.
- 1.3 The parties shall co-operate with each other and shall as promptly as is responsibly practical, relevant agreement.

CLAUSE 2: SCOPE OF THE MOU

- 2.1 Industrial Training & Visits: Industry and Institution interaction will provide an insight into the latest developments / requirements of the industries; the Second Party to permit the Faculty and Students of the First Party to visit its group companies and also involve in Industrial Training Programs for the First Party. - 2.2 Guest Lectures: Second Party to extend the necessary support to deliver guest lectures to the students of the First Party on the technology trends and in house requirements.
- 2.3 Placement of trained students: Second Party will actively engage to help the delivery of the training and placement of the students of the First Party on the technology trends and in house requirements.
- 2.4 There is no financial commitment on the part of the **Basaveshwar Engineering College (Autonomous)**, **Bagalkote**, the First Party to take up any program mention in MOU. If there is any financial consideration, it will be dealt separately.

CLAUSE 3: VALIDITY

Either Party may terminate this MOU at any time, for any, or no reason upon 30 days written notice to the other Party, or immediately if a Party has failed to cure a material breach of this MOU 10 days after receiving written notice of such breach.

CLAUSE 4: RELATIONSHIP BETWEEN THE PARTIES

5.1 It is expressly agreed that First Party and Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership.
